

## **New York Obstetrical Society**

By-Laws 2026

*These are the official Society By-Laws.*

### **BY-LAWS**

#### *Preamble*

The New York Obstetrical Society is an organization consisting of Obstetrician- Gynecologists who are leaders in the field of obstetrics and gynecology from the New York metropolitan area, and who are dedicated to the betterment of obstetrics and gynecology through clinical, academic, scientific, and political endeavors.

#### **Chapter I**

##### *Members*

1. The Society shall consist of Fellows, Life Fellows, Associate Fellows, Honorary Fellows, and Corresponding Fellows. The number of Fellows shall be limited to 185, but the total number of Life Fellows, Associate Fellows, Honorary Fellows, and Corresponding Fellows shall be unlimited. Fellows of the Society shall be deemed the Members of the Society in accordance with the Not-For-Profit Corporation Law of the State of New York.
  - a. **Fellows:** Those eligible to election as Fellows shall be physicians in good standing who live and/or work in the New York Tristate area (New York, New Jersey and Connecticut) within a 60-mile radius of the designated meeting location, and are Diplomates of the American Board of Obstetrics and Gynecology. Any variation in the latter requirement to be on recommendation of the Council.
  - b. **Life Fellows:** Upon attaining the age of 70 or upon completion of 25 years of membership, a Fellow shall be offered the opportunity to become a Life Fellow. This change shall be made by the Secretary effective the first of October of each calendar year. Life Fellows shall continue to enjoy all the privileges of the Society except the right to vote and to hold office unless they continue to pay dues. Fellows, who have been offered the opportunity to become Life Fellows, may refuse to become Life Fellows if they desire the opportunity to retain their rights to vote and to hold office in the Society or for any other reason, which they are not required to disclose. Once offered and declined, they may in any given year (if they notify the Society Secretary prior to October 1<sup>st</sup> of that year) choose to change their status to Life Fellowship. This change must be at their own initiative, the Society Secretary will NOT remind them each year of their opportunity to change their status after the first year is declined. Life Fellows shall continue to pay the cost of dinners for themselves and their guests.
  - c. **Associate Fellows:** Those eligible for election as Associate Fellows shall be members of allied specialties or sciences whose work brings them into close association with the practice of Obstetrics and Gynecology and who reside in or near New York City. Their election shall be by the same procedure as that for Fellows. Their status shall be the same as that of Life Fellows. They may not vote or hold office.

- d. **Honorary Fellows:** Honorary Fellows may be granted to eminent Obstetricians and Gynecologists. Their status shall be the same as that of the Associate Fellows. Elections shall be by ballot at any stated meeting at which notice of such election has been given.
- e. **Corresponding Fellows:** Corresponding Fellows are those Fellows and Associate Fellows who move beyond the New York Tristate area (New York, New Jersey, and Connecticut) more than a 60-mile radius of the designated meeting location to live or work. They shall continue to receive programs and may enjoy all the privileges of the Society but may not vote or hold office.

## Chapter II

### *Officers*

1. The officers of the Society shall be a President, a First Vice-President, a Second Vice-President, a Secretary, an Assistant Secretary, and a Treasurer. The six officers of the Society and four other Fellows, who shall be the four Immediate Past Presidents of the Society, shall constitute the Council of the Society.
2. A vacancy in the list of officers or of the other members of the Council shall be filled by the Council for the unexpired term.
3. In the event that a Council Member resigns, is removed, or is otherwise unable to complete their term, the vacated position shall not be filled directly. Instead, any replacement appointed or elected to the Council shall enter at the entry-level position of the Council, as defined by these Bylaws. Subsequent advancement or assignment within the Council shall occur in accordance with the Society's established procedures and in a manner that serves the best interests of the Society.

## Chapter III

### *Duties of Officers*

1. The President shall preside at all meetings, shall appoint all committees not otherwise provided for, shall be an ex-officio member of all committees, and shall be the Chairperson of the Council.
2. The First Vice-President shall, in the absence of the President, perform the duties of the latter. In addition, the First Vice-President shall maintain the Standard Operating Procedure (SOP) document for the Council and incorporate all changes decided upon by Council quorum. Five members shall constitute a quorum. The First Vice-President will review the by-laws for revisions to be presented to the Council for approval prior to submission to the general members for approval.
3. The Second Vice-President shall support the President and Vice-President in their duties and perform their duties in their absences. In addition, having performed the duties of Treasurer the year before, the Second Vice-President shall be responsible for business development ideas and implementation, including but not limited to, securing outside sponsorship for any/all meetings possible. All Council members commit to active engagement to invite possible sponsors to help underwrite costs of Society meetings, and work with the Second Vice-President to secure and contract these potential sponsors.

4. The duties of the Secretary shall be as follows:
  - a. To keep a record of the proceedings of the Society and of the Council.
  - b. To conduct the correspondence of the Society.
  - c. To send all members of the Society a notice of each meeting (electronically by email) at least 5 days before the meeting date in conjunction with the Society administrator. Such notice shall include the title of each presentation with the name of the author, and any other notices of importance. The notice of the Annual Meeting shall contain the names of approved candidates for Fellowship or Associate Fellowship for balloting, as well as the report of the Nominating Committee.
  - d. To perform such other duties as may be designated by the Council.
  - e. To notify in writing any Fellow who fails to pay dues leading to termination of membership. This review of Fellows in arrears shall occur in conjunction with the Treasurer by the first meeting of the general membership annually.
  - f. To report at the Annual Meeting the number of Fellows of the Society as of the date of the report, together with a statement of increase or decrease in such number during the year immediately preceding the date of the report. He/she shall make a statement of the place where names and places of residence of the current Fellows may be found.
5. The duties of the Assistant Secretary shall be as follows:
  - a. To perform the duties of the Secretary in the absence of that officer.
  - b. To perform such other duties as may be designated by the Council.
  - c. To record the minutes at meetings of the Council and the Society.
6. The duties of the Treasurer shall be as follows:
  - a. The Treasurer reviews the list of members in arrears and works with the Secretary to notify members of the status of their membership dues.
  - b. The Treasurer works in collaboration with the financial team of the Council to review financial statements of the council and reviews members in arrears as needed.
  - c. The Treasurer makes recommendations to the Council regarding dues increases or decreases based on the financial wellness of the Society.
  - d. To present with the President at the Annual Meeting, and such other times as requested by the President or Council, a report of the financial condition and activities of the Society. The account at the Annual Business Meeting shall be audited, prior to the meeting, by two Fellows appointed by the President.

The annual fiscal report shall be certified by the Treasurer, and shall include the following:

1. The assessments and liabilities of the corporation at the end of a 12-month fiscal period.
2. Principal changes in assets and liabilities during the year immediately preceding the date of the report.
3. Revenue or receipts of the Society both unrestricted and restricted for the year immediately preceding the date of the report.
4. Expenses or disbursements of the Society during the year immediately preceding the report.
5. Payment of annual taxes as required by New York State.

#### Chapter IV *Committees*

1. **MEMBERSHIP.** The Immediate Past President shall chair the Membership Committee. This Committee shall be responsible for reviewing all applications for potential new members, setting application receipt deadlines, and making themselves available to perform the in-person or virtual interviews. After application review and interviews, this group will present a slate of proposed candidates to the Council. If the Council approves, they will present that slate of potential applicants to the membership for approval.

The Committee shall consist of three non-Council Members and two Council Members, who shall be the Secretary and the Immediate Past Chairperson of the Membership Committee. The Chair shall be the Immediate Past President. The total complement is 6 individuals.

2. **NOMINATING.** The President shall appoint the Nominating Committee and its Chairperson. This Committee shall be responsible for nominating one or more proposed candidates as the new Council member each year, and ascertaining if those individuals are willing to serve as President (when their time comes) and on Council for a total period of ten years, during that time to remain active members and fulfill all duties as Council members. The entire Council must vote on which candidate shall be offered admission to the Council and Presidential succession. In the event of a tie (as Council has an even 10 members), the President shall cast the deciding vote.

On the first meeting of each academic year, the new President will announce to the membership a call for interested members to nominate themselves or a Society member colleague in good standing to join the Council as the new member for the following academic year. All nominations must be sent to the President by January first of that calendar year, accompanied by a statement

of one paragraph stating the party's interest and commitment to serving the Society through Council leadership. The nominating committee will then choose from those members who put themselves or a colleague forth for consideration.

This Committee shall consist of three Council Members and two non-Council Members. The total complement is 5 individuals.

#### Chapter V *Meetings*

1. Meetings shall be held on the second Tuesday of every month from October through May or on other Tuesdays at the discretion of the President.
2. The Annual Meeting shall be held on the second Tuesday of May unless otherwise designated by the Council.
3. Guests will be permitted at the Presidential Address, although they will not be permitted to stay for the Business Meeting.
4. Special meetings may be called at the request of 25 Fellows of the Society. A special meeting shall be held at a time and place to be designated in the notice of the meeting and the agenda of the meeting shall be limited to that specified in the notice.

#### Chapter VI *Council*

1. The Council shall meet as often as the needs of the Society require or at the call of the President. Five members shall constitute a quorum.
2. The Council shall arrange the program and the place of meetings for slated meetings.
3. It shall make policy decisions, referring such questions as it considers necessary to the Membership as a whole and document such policy decisions into the Standard Operating Procedure Document when appropriate.
4. It shall receive and act upon all complaints.
5. It shall constitute a board of trial for all offenses against the Society committed by a member or for conduct unbecoming a member of the Society. Rules of Order, Art. XIII Sect. 75.
6. The Council shall be the equivalent of a Board of Directors as indicated in the Not- For-Profit Corporation Law of the State of New York.

## Chapter VII

### *Election of Fellows*

1. Candidates for Fellowship and Associate Fellowship shall be nominated in writing by a Fellow or Life Fellow and shall be endorsed by two Fellows or Life Fellows. Council members may not nominate or endorse candidates for Fellowship. Such nominations shall be sent to the Secretary and transmitted by them to the Membership Committee. Each sponsor shall transmit a letter of recommendation to the Membership Committee. If individuals do not hold the rank of Associate Professor or above, they must demonstrate academic productivity by presenting a paper that they have published or submitted for publication within the past 5 years of which they have first authored to the Membership Committee. Exceptions may be made by the Council for candidates with demonstrated significant leadership contributions in the areas of medical education or patient safety/quality (e.g. Directors of Resident, Medical Student, or Fellow Education, Directors of QA/QI or Simulation Programs, etc.).
2. The Membership Committee shall examine the credentials and ascertain the standing of a candidate and interview the candidate personally. If the Membership Committee approves of a candidate, their name shall be forwarded to the Council for approval. The Council shall then review the application and if it approves, present the name of the candidate to the Society. The name of such candidate(s) shall be sent electronically (by email) to the Membership at least two weeks before the May Business meeting with the names of the proposer and endorsers. If there are objections, these may be made to any Member of the Council, and the Council shall then discuss. If there are none, or if Council still agrees to present this candidate to the Membership, the names of all such candidates – along with the names of their proposers and endorsers – shall be presented at the Annual Business meeting for a formal vote by the present members.
3. Candidates shall be voted upon at the Annual Meeting. For election, a candidate must be approved by a majority of Fellows present and voting.
4. Candidates for Honorary Fellowship must be approved by a majority of the Fellows present and voting.

## Chapter VIII

### *Termination of Membership*

1. When Fellows and Associate Fellows move to a distance that precludes active participation, they may elect to become Corresponding Fellows or termination of their membership shall be automatic. Failure of participation by reason of illness shall not be a cause for termination of membership.
2. Any Fellow in arrears for dues or indebtedness for one year will, after due notification in writing by the Treasurer and Secretary, shall forfeit his/her membership by vote of the Council.
3. Fellows who lose their membership due to non-payment must be approved by the Council (by vote) and pay any dues in arrears, in order to re-join.
4. If a Fellow's license to practice medicine is suspended, his/her membership in the Society will

be suspended. If his/her license is revoked, then membership shall be revoked.

## Chapter IX

### *Dues*

1. Annual dues for Fellows shall be recommended by the Council and approved by a majority of the Fellows present and voting at a regular meeting. Notice of such proposal shall appear in the announcement of the meeting. The fiscal year shall end at the conclusion of the Annual Meeting. Bills shall be due when presented. Late fees as approved by Council shall apply.
2. Associate Fellows, Honorary Fellows, Life Fellows and Corresponding Fellows shall not be subject to annual dues but shall be billed for dinner at meetings which they and/or their guests attend. The amount of the dinner fee is to be determined by the Council.

## Chapter X

### *Amendments*

By-Laws may be repealed, amended, or suspended by two-third's vote of the voting members present at a regularly scheduled meeting. At the meeting preceding the meeting at which the vote will occur, a notice of the proposed change(s) shall be presented. The electronic (email) notification of the meeting at which the vote will occur will also carry a notice of the proposed change(s).

## Chapter XI

### *Parliamentary Authority*

Parliamentary authority shall be Roberts Rules of Order, most recent version.

## Chapter XII

### *Seal*

The Seal of the Society is not available in this electronic version of the bylaws, but is contained within the official print version of the bylaws.

## Chapter XIII

### *Implementation*

These By-Laws shall be effective immediately upon adoption.
